Online privacy statement

Christian Foundation for Children and Aging is committed to respecting your online privacy and security. Our website has been developed to allow you to visit us on the Internet without identifying yourself or revealing any personal information. If you choose to provide us with information from which you can be personally identified, it will be used exclusively to support your relationship with CFCA.

Awareness

We provide this online privacy statement to inform you of our privacy and security practices, and to disclose the way your information is collected and used. For your reference, a link appears on our homepage and at the lower left of every CFCA web page.

Data security

To prevent unauthorized access and to maintain the accuracy and integrity of stored data, CFCA has implemented comprehensive control measures and processes utilizing current technology. CFCA uses Internet Encryption Software, Secure Socket Layer (SSL) Protocol when collecting or transferring sensitive data such as credit/debit card and banking information. Entered data is encrypted at your browser and sent via the Internet in an encrypted format. It is then de-encrypted at our server. Once we receive your personal and financial data, it is only accessible to staff members authorized to access your account information and process these transactions.

Information we collect

Information collected on our website is subject to CFCA's online privacy policy. On certain CFCA web pages you may become a sponsor, make donations or request materials. The types of personally identifiable information we collect on these pages may include your name, contact and mailing information, telephone, email address, contribution type, credit or debit card, and banking information when the payment method is via electronic funds transfer (EFT). Data collected online may also be combined with information you may provide if you become a CFCA sponsor or donor.

How we use it

The information we collect may be used to improve the content of our web pages, to notify visitors about updates to our website, or it may be used by us to contact sponsors, donors and others regarding CFCA programs when prior opt-in approval has been given. CFCA uses your information to better understand your interests and to provide the best possible service to those who support our mission efforts. Specifically, your information allows us to help facilitate a transaction, respond to inquiries, and provide updated information to you regarding your sponsored friend and other events. Credit-card numbers and banking information are used only for payment processing and are not retained for other purposes.
